The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Ron Sweers, and Jerry J. Tlach present. Absent: none.

The minutes of January 9, 2017 meeting were read and approved.

On motion by Supervisor Tlach, seconded by Supervisor Sweers, and carried unanimously, the Board gave approval to the following: Hancock County Treasurer's semi-annual report for the period of July 1, 2016 to December 31, 2016. Signed the Iowa Communities Assurance Pool (ICAP) Anniversary Information Acknowledgement form with three coverage changes.

On motion by Supervisor Sweers, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following: Accepted the 2015-2016 independent auditor's report from Renner & Birchem, PC. Class C liquor license with outdoor service & Sunday sales for Slippery Elm, Inc. doing business as Slippery Elm Golf Course.

On motion by Supervisor Tlach, seconded by Supervisor Sweers, the Board gave approval to the following: Increased the city communication contribution rates, with a three year transition period, beginning for Fiscal Year 2017-2018 cities will pay 25% of the entire communications budget, for Fiscal Year 2018-2019 cities will pay 37.5% of the entire communications budget, and for Fiscal Year 2019-2020 cities will pay 50% of the entire communications budget, Ayes: Sweers, Tlach. Nays: Greiman. Motion carried.
