The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Ron Sweers, and Jerry J. Tlach present. Absent: none.

The minutes of May 26, 2015 and May 29, 2015 meetings were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Sweers and carried unanimously, the Board gave approval to the following: Set June 15, 2015 at 10:00 a.m. as the date and time for a public hearing for the vacation of a portion of Ladd Avenue lying between sections 23 and 24, Britt Township. Permit for Magellan Ammonia Pipeline, L.P., Tulsa, Oklahoma, for underground construction under the open ditch of Drainage District #81 in the SE ¼ of the SW ¼, section 22, Concord Township.

On motion by Supervisor Sweers, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Five day class B beer permit for Hancock County Agricultural Society, Britt, Iowa, with outdoor service beginning June 26, 2015. Final payment voucher for bridge project BROS CO41(112)--8J-41. Utility permit for Prairie Energy Cooperative, Clarion, Iowa for underground electric cable located at 1869 Quail Avenue in the SE ¼ of the NE ¼ of section 15, Liberty Township.

On motion by Supervisor Greiman, seconded by Supervisor Sweers, the Board unanimously approved the following Resolution:

### **ROAD CLOSING RESOLUTION**

As per Section 306.41 Code of Iowa be it resolved that the Board of Supervisors of Hancock County hereby declare closed temporarily the following roads in Hancock County due to construction, reconstruction, maintenance or natural disaster. This resolution shall become effective upon placement of temporary road closure signs and shall expire when the said temporary signs are removed upon completion of said project.

### **DESCRIPTION OF ROADS AFFECTED**

R-20 or Deer Avenue from U.S. #18 North to the Winnebago County line.

B-14 or 330<sup>th</sup> Street from the Kossuth County line to the Junction of R-20 or Deer Avenue

On motion by Supervisor Sweers, seconded by Supervisor Greiman and carried, the Board authorized the County Auditor to issue checks for the claims on file this date, June 1, 2015. A full listing of all claims paid in June, 2015 will be published in the June 15, 2015 minutes.
