The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Ron Sweers, and Jerry J. Tlach present. Absent: none.

The minutes of March 6, 2017 meeting were read and approved. On motion by Supervisors Sweers, seconded by Supervisor Tlach, and carried unanimously, the Board approved to amend the previously adopted minutes of February 27, 2017.

On motion by Supervisor Sweers, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following: Set April 3, 2017 at 11:00 a.m. for opening of sealed audit bid proposals. Exchange of Geographic Information Systems (GIS) data for use with Hancock County drainage district map update project with I & S Group.

A public hearing was held at 9:15 a.m. regarding the vacation of a portion of Daggett Road (225th Street/Old US Highway 18) located in section 27 of Britt Township. Present were Hancock County Board of Supervisors Greiman, Sweers, and Tlach; Hancock County Auditor Eisenman, and Assistants to the Engineer: Alan Bredlow and Shaun Hackman. Present from the public were Bob Kern and Pauline Turner. No written or oral objections had been received.

On motion by Supervisor Tlach, seconded by Supervisor Sweers and carried unanimously, the Board gave approval to the following Resolution:

RESOLUTION TO VACATE A COUNTY ROAD
Hancock County

WHEREAS, This being the date and time set for the hearing on the proposed vacation and closure of a portion of Hancock County Secondary Road, described as follows:

That portion of Daggett Road No. 84 (225th St/Old U.S. Highway #18), established on September 6, 1875 (See Road Record Book #1, page 196) and legally changed to Iowa Highway #19 on July 1, 1920, then changed to the Atlantic-Yellowstone-Pacific Highway September 1923 and then changed to US Highway #18 in November 11, 1926 and then changed to Iowa Highway 424 in November 1961, and then by Quit Claim Deed from State of Iowa to Hancock County on March 1, 1982. The intention of this road closure is to vacate the entire segment of public road (original and with modifications) commencing at Drainage Ditch 1 & 2 (west Branch Iowa River) thence running Northeasterly to the south Right of Way line of Canadian Pacific Railroad all lying in SE ¼ of the NE ¼ of the SW ¼ and the SW ¼ of the NW ¼ of the SE ¼ of Section 27, T-96N, R-25W, Britt Township.

WHEREAS, No objections have been received, either in writing or by persons present.

NOW, THEREFORE BE IT RESOLVED by the Hancock County Board of Supervisors that the subject section be ordered vacated and closed.

No further business to come before the Board, motion made to adjourn at 1:13 p.m. by Supervisor Tlach and carried. All Supervisors present voting, "Aye," session to adjourn and will meet again on March 20, 2017.
