The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Ron Sweers, and Jerry J. Tlach present. Absent: none.

The minutes of April 25, 2016 meeting were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Tlach, and carried unanimously, the Board gave approval to the following: Approved the quote from Eenhuis Construction, LLC, Garner, Iowa, as the best and only quote submitted for the repair of the sidewalk at the Public Health Building for \$1,170. Appointment of Jason Lackore as Weed Commissioner. Signed Wellmark documents: Wellmark rate sheet, Medicare Secondary Payer (MSP) Addendum, and Summary of Benefits and Coverage (SBC) Employer Data Form.

On motion by Supervisor Tlach, seconded by Supervisor Greiman, and carried unanimously, the Board gave approval to the following: Approved the quote from Burtness-Lundgren Plumbing & Heating, Inc., Clear Lake, Iowa, as the best of two quotes submitted for the replacement of the air conditioning unit in the communications room at the Public Health building for \$4,362. Hiring of Austin Kropp, Conservation Aide, effective May 9, 2016 at \$9.25 per hour, hiring of Daniel Schreur, Conservation Aide, effective May 18, 2016 at \$8.85 per hour, hiring of Ron Brass, Conservation Park Mowing, effective May 3, 2016 at \$8.85 per hour. Approved the County Mobile Device Policy. Approved changing the manner of recording of Board of Supervisor's meetings to audio recording as soon as the equipment to be purchased is received. Hiring of Hunter Hiscocks, summer help in the Secondary Road Department, effective May 11, 2016 at \$10.25 per hour, hiring of Jerry Weiskamp, summer help in the Secondary Road Department, effective May 16, 2016 at \$12.50 per hour. Signed the revised health insurance rates to reduce rates by one cent to account for payroll deduction of health insurance.

On motion by Supervisor Tlach, seconded by Supervisor Greiman and carried, the Board authorized the County Auditor to issue checks for the claims on file this date, May 2, 2016. A full listing of all claims paid in May, 2016 will be published in the May 16, 2016 minutes.
