The Hancock County, Iowa, Board of Supervisors met in adjourned session on the above captioned date pursuant to adjournment with Supervisors Florence (Sis) Greiman, Ron Sweers, and Jerry J. Tlach present. Absent: none.

The minutes of April 27, 2015 meeting were read and approved.

On motion by Supervisor Greiman, seconded by Supervisor Sweers and carried unanimously, the Board gave approval to the following: Reviewed and accepted the Central Iowa Juvenile Detention Center Audit Report for Fiscal Year ending June 30, 2014. Approved and signed the Emergency Medical System Development Grant application for fiscal year 2016.

On motion by Supervisor Sweers, seconded by Supervisor Greiman and carried unanimously, the Board gave approval to the following: Approved health insurance rates for employees with employees choosing the single rate of the 500/1,000 deductible plan paying 1 percent and employee choosing family coverage of the 500/1,000 deductible plan paying 6 percent and employees choosing the single rate of the 750/1,500 deductible plan to be paid by employer and employee choosing family coverage of the 750/1,500 deductible plan paying 3.5 percent. No increase in rates for dental with single rate to be paid by employer and employee choosing family coverage paying the difference between the single and family rates. No change in Avesis vision care, with a renewal period of July 1, 2014 through June 30, 2016, with single rate to be paid by employer and employee choosing family coverage paying the difference between the single and family rates.

On motion by Supervisor Greiman, seconded by Supervisor Sweers, the Board unanimously approved the following Resolution:

EMERGENCY ROAD CLOSING RESOLUTION

As per Section 306.41 Code of Iowa be it resolved that the Board of Supervisors of Hancock County hereby declare closed temporarily the following roads in Hancock County due to construction, reconstruction, maintenance, or natural disaster. This resolution shall become effective upon the placement of temporary road closure signs and shall expire when the said temporary signs are removed.
